1. Purchase terms

- 1.4. We are not obligated to execute the purchase in case the payment fails or is denied by the payment service provider.

- 1.6. Purchases shall be made only from one's own Customer account.
- 1.7. We reserve the right to refuse any order you place with us. We may, in our sole discretion, limit or cancel quantities purchased per person or per order.
